

ORDINANCE NO. 144326


An Ordinance designating all of Blocks 1 through 32 and south, east, north, west and central parks, Ladd's Addition, generally bounded by SE Hawthorne, SE 12th, SE Division, and SE 20th, and as shown on the attached map as the Ladd's Addition Historic Conservation District, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That the Portland Historical Landmarks Commission and the Portland City Planning Commission have recommended that all of Elocks 1 through 32, and south, east, north, west, and central parks, Ladd's Addition, generally bounded by SE Hawthorne, SE 12th, SE Division, and SE 20th, be designated a Historical Conservation District as set forth in their report dated August, 1977 (Council Calendar No. 2797 for 1977).
- 2. That the City Aud tor notified the owners of property within the area of said Historic Conservation District designation that a hearing on said proposal would be held at 2:08 p.m., Wednesday, August 17, 1977, in the Council Chamber of the City Hall in the City of Portland, Oregon, at which time and place said hearing was held, and that the recommendation of the Portland Historical Landmarks Commission and the Portland City Planning Commission should be adopted.

NOW, THEREFORE, THE Council directs that all of Blocks 1 through 32, and south, east, north, west, and central parks, Ladd's Addition, generally bounded by SE Hawthorne, SE 12th, SE Division, and SE 20th, is hereby designated as the Ladd's Addition Historic Conservation District and thus subject to the protection and regulations of Chapter 33.120, Planning and Zoning, of the Code of the City of Portland, Oregon and the City Auditor hereby is authorized and directed to have a copy of this ordinance recorded in the Deed Records for Mulanomah County.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in carrying out the desires of the Commissions, all in the public interest; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
